- 1. 2019 we have had 78 calls to date.
- 2. 2018 there were 67 calls for the same time period.
- 3. We are currently up 11 calls from last year's numbers.
- 4. Comstar report: Gross commitments: \$45,198.00. Total collected for 2019 to date \$28,089.00.
- 5. We have received a Grant for 2 ACR4 child restraint systems that will replace our soon to be outdated car seats. This was one of the items we had looked at covering with the CRF. They run about \$860.00 apiece.

We are also working on a grant to receive portable Carbon Monoxide detectors which are also something we will be required to carry in the future. Both acquisitions will have no monies coming from the town or service.
