- S. Durkin commented that currently there aren't any active committees. The Back Flow Committee hasn't started; there was a committee for the Safety building (2 years ago). Sean said there is supposed to be a committee for the Electrical Coop. J, Weagle said Sean would be getting an email about it this week from him with dates and times. The members are J. Weagle, S. Durkin, A. Rossetto and David Auger. There isn't a minimum # of people required. Sean said there are other communities that are ahead of us on this that are already pushing to join. Dave Auger has talked to someone in Berlin about this. Al said Canterbury, NH is in the program and saving money.

Al suggested that Sean keep an eye out for legislation adjusting it; people that have solar can't use it, but they were looking to include those with solar. Sean needs to check into net metering.
