- **1. Chairman opens the meeting:** Jim opens the meeting and asks for a motion to accept minutes of April 5, 2021.

#### 3. Selectmen Business:

a. Department Head Business: Ambulance and Police

James Gibson for Ambulance reports that calls were down from last year (2020). Also mentioned was the Radio meeting to be held April 29<sup>th</sup> at 6:30pm in Lancaster.

Chief Peter Pelletier reports that they've had 290 calls since last meeting. The calls are growing since the department is getting stronger. He will write an article in the newspaper on this.

Asked by Chief Pelletier to the Select Board that the Kapson house on 2<sup>nd</sup> Street needs to be secured as it is dangerous.

Jim brought up to Chief Pelletier that there was a complaint of cars parked on the road at the Fanton property on Cumberland Street, a car was parked in the Municipal Building lot by Cromptons all winter and could these be taken care of by the department.

Min brought up that there was also a complaint about a dog on Goulet Street that needed to be looked into.

b. Discussion of utility change letter - Terry & Al Beland

Al asks for an abatement on his rental property and made a complaint about the change from residential to commercial.

Norm Cotter stated that letters need to be sent to everyone who originally got their classification changed and let them know that if they can prove the tenant pays the utilities they can get an abatement and change in classification.

The Select Board said that if anyone had an issue they could call.

Norm stated that he felt there needed to be some clarification.

The Select Board approved Al's abatement.
