- 1. Chairman opens the meeting: Keith opens the meeting and asks for a motion to accept minutes of previous meeting.

- 3. **Department Head Business:** Ambulance and Police Depts.

Jim Gibson's notes read: 181 calls to date compared to 159 last year.

Chief Pelletier reports: 201 call for service which included 44 car stops. Still trying to get the numbers from the new system.

Training continues on the new log reporting system. It has been very busy, there are 30 pages of activity.

Time was spent in Lancaster helping with a fugitive search. The fugitive eventually surrendered and was returned to State Prison.

With the hiring of more officers the Police Dept., is getting closer to 20 to 24 hour coverage.

Jim adds that fires are under the jurisdiction of the Precinct. More discussion on things other than fireworks and furniture being burned, like mattresses and there is concern for fire and hazardous contamination.

- **9. Adjournment:** Jim makes motion to adjourn, Bill seconds, all in favor, 3-0.


