4. Discussion of presenting to the board the Hawker, Peddler and Itinerant Ordinance. Discussion of exemptions and purposes of the ordinance. Changed one of the exemptions for yard sales and non profit parties. Discussion of the exemptions and how they pertain to our town. Al was opposed to having paper permits for the police department and Becky but without them there would be no way to communicate. Al agreed that If the ordinance came as a request from the police department then he was in agreement. We decided to go forward bringing it to the board.

5. Discussion of bringing to the board for Ordinance for Noise & Disorderly Conduct. Discussion of the name of the ordinance. Julie advised that this also came directly from the police department. Officer Dennis Miccuci had prepared this for the ordinance committee to review. Discussion of the different businesses in the town and some exemptions that are required by the state law. Everyone was in agreement with a few minor changes and the addition of Jake breaks to our ordinance that is in the State RSA. Discussion of giving the speedway a seasonal permit for their events. Discussion about the fines not matching the state fines and we agreed to make the ordinance match the state RSA for fines. Julie was going to retype to present to the Board in May 6, 2019.

6) Discussion and select ordinance(s) to review at next meeting, May 13th at 6pm. Ann asked what happened to the pool ordinance and the open container ordinance. Julie explained that they were trying to do too many each meeting so they decided to focus on just one and see it through. He is going to have Becky take it out for our next meeting. Ann offered to look at the book ahead and make a list of what is in there and al thought it would be better to just all look at the same time.
