The Annual Town Election for the Town of Northumberland and Northumberland School District was declared opened at 11:00 AM, Tuesday, March 8, 2022, to act upon the subjects hereinafter mentioned. At 7:00 PM Moderator Young announced that the polls were closed, and the counting process began.

Article 04 To set the compensation of Town elected official

To see if the Town will vote to set the annual compensation of the elected Town Clerk/Tax Collector. This amount is included in the Town operating budget in Article 8.

Town Clerk/Tax Collector \$50,000

In the event the Selectmen make a cost-of-living increase to Town full-time employee compensation, the Town Clerk/Tax Collector compensation shall also increase by a corresponding amount. The Town Clerk/Tax Collector shall also receive all benefits offered to Town of Northumberland full time employees. If this position is filled by someone other than the current Town Clerk/Tax Collector, compensation will be adjusted upon election / appointment to an amount commensurate with experience and level of certification.

Article 05 Operation and maintenance of the water department

To see if the Town will vote to raise and appropriate the sum of \$353,709 for the purpose of operating and maintaining the water department. Said funds to be raised from the water user

fees. Any shortfall in the water user fees will be made up from the accumulated surplus in the "regular water account". No amount to be raised from taxation. (Recommended by Board of Selectmen 3-0)

Article 06 Operation and maintenance of the sewer department

To see if the Town will vote to raise and appropriate the sum of \$347,833 for the purpose of operating and maintaining the sewer department. Said funds to be raised from sewer user fees. Any shortfalls in the sewer user fees will be made up from the accumulated surplus in the "regular sewer account". No amount to be raised from taxation. (Recommended by Board of Selectmen 3-0)

Article 07 COPS Grant

To see if the Town will vote to approve a 48-month CHP (COPS Hiring Program) Grant Agreement with USDOJ for the purpose of the Town's hiring and employment of two additional full-time Police Officers for at least 48 months; and further to raise and appropriate \$142,428 for the 2022 wages and benefits for the two additional Police Officers, with \$71,214 to be raised by taxation and \$71,214 from Grant revenue. Under the terms of the CHP Grant, USDOJ will pay the Town a total of \$250,000 during the first 36 months to offset the Town's costs. The total estimated cost of employing two full-time Police Officers for 48 months is \$728,188, and the Town's share of this cost will be \$478,188, broken down as follows:

Article 14 Locality Grant

To see if the town will vote to raise and appropriate \$56,000 for the purpose of purchasing safety and emergency equipment needed as a result of or in response to the health crisis and its negative effects. \$50,000 to come from a State Grant and \$6,000 to come from unassigned fund balance. If the grant is not fully received, the remainder to be raised through taxation. (Recommended by Board of Selectmen 3-0)

Article 15 Wellhead land purchase

To see if the Town will vote to raise and appropriate \$74,900 to acquire from Roger D. Mayhew et al a certain 19.05-acre parcel of land upon which the municipal wells are located and is identified on the Town's tax map as Map 213, Lot 004, for the purpose of protecting the Town's water sources and well heads. \$37,450 (50%) to come from the State's Drinking Water Ground Water Trust Fund and the remaining 50% to come from unassigned fund balance. No taxes will be raised with this article. (Recommended by Board of Selectmen 3-0)
